#### a. Resolution #2022-0036 - Early Reimbursement for Meals, FDIC

On motion of Commissioner McConnell, seconded by Commissioner Barry, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, the Victor Fire District Policy provides reasonable reimbursement for per diem travel expenses, including reimbursement for meals for actual expenses verified through original receipts not to exceed IRS per diem meal allowance rates;

WHEREAS, to eliminate using the District credit card for meals, Chief Eifert has requested the Fire District provide the funds for meals to the individual attendees for FDIC at the full IRS reimbursement rate in advance of the conference;

WHEREAS, Treasurer McAdoo has provided the current Federal per diem rates for Indianapolis, Indiana, shown in Appendix A, and determined the total funds for meals per person will be \$448.50; now, therefore, be it

RESOLVED, that the Board of Fire Commissioners hereby authorizes the Treasurer to issue an early reimbursement for meals for Deputy Chief Steve Lamarco, Assistant Chief Mark Militello, and Lieutenant Mike Murphy with the understanding that any expenses not determined to be consistent with the travel policy shall be refunded to the District within 30 days of notification; and,

RESOLVED that the expenses for this training will be assigned to A3410.403.11.3 Training -FDIC

### b. <u>Resolution #2022-0037 - Purchase Authorizations</u>

## c. <u>Resolution #2022-0038 - Motion to approve budget transfers</u>

On motion of Commissioner McConnell, seconded by Commissioner Kowal, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, to maintain balanced budget lines within the 2022 budget, Treasurer McAdoo recommended inter-budget transfers as fully described in Attachment A; and,

WHEREAS the Board of Fire Commissioners have reviewed and discussed the transfers and found they are consistent with good financial practices; now, therefore, be it

RESOLVED the Board of Fire Commissioners approve the inter-budget transfers as shown.

# d. <u>Resolution #2022-0039 – Authorization for Firefighters to Attend NYSAFC</u> <u>H.O.T. Classes</u>

On motion of Commissioner Barry, seconded by Commissioner McConnell, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, General Municipal Law 72-g and Victor Fire District Policies require training opportunities at the regional level must be authorized by the Chief and approved by resolution of the Board of Fire Commissioners prior to attendance;

WHEREAS, the New York State Association of Fire Chiefs (NYSAFC) conducts an annual conference and fire expo which includes hands-on-training (HOT) classes designed to enhance firefighting skills in a variety of areas;

WHEREAS, Chief Eifert wishes to send up to four firefighters to a HOT class scheduled between June 16 – 18, 2022, utilizing the 2761 vehicle, in lieu of attending the Ohio Crash Course Program;

WHEREAS the Board of Fire Commissioners have reviewed Chief Eifert's request, and finds that it necessary and appropriate to authorize this training;

RESOLVED, the Board of Fire Commissioners authorizes Chief Eifert to designate four firefighters to attend the one-day training for a NYSAFC HOT class between June 16 – 18, 2022, at the Syracuse Fire Department Training Center;

RESOLVED, that the attendees are authorized to use one of District Credit Cards for expenses on the condition they review the travel policy with the Treasurer prior to departure and with the understanding that any expenses not determined to be consistent with the travel policy shall be refunded to the District within 30 days of notification;

RESOLVED that the expenses for this training will be assigned to A3410.403.11.7 Training -Crash Course

#### e. <u>Resolution #2022-0040 - Authorization for Travel to Harrisburg Fire Expo</u>

On motion of Commissioner McConnell, seconded by Commissioner Barry, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, District Policy requires Board of Fire Commissioner approval for attendance for all travel and seminars on behalf of the Fire District prior to an event;

WHEREAS, the Truck Committee desires to have up to three of their members attend the Harrisburg Fire Expo on May 20 & 21, 2022, to further their research on replacing the existing rescue truck;

WHEREAS, the Board of Fire Commissioners have reviewed this request and finds it is in the interest of the Fire District to support attending this event; now, therefore, it is

RESOLVED to authorize Firefighters Jason Maier, Glenn Lockwood, and Joseph Murphy to attend the Harrisburg Fire Expo May 20 & 21, 2022, at Harrisburg, PA, including hotel rooms for two nights, as well as meal, mileage, and tolls for use of personal vehicle reimbursement up to the full IRS reimbursement rates upon demand; and,

RESOLVED that the expenses for this training will be assigned to A3410.403.11.5 Training – Conferences/ Trade Shows.

# f. <u>Resolution #2022-0041 – Appointment of volunteer firefighter Linsey</u> <u>McConnell.</u>

On motion of Commissioner Barry, seconded by Commissioner Keyes, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, pursuant to Town Law §176, after selection by the fire company, volunteer members of a fire company shall be appointed by the Board of Fire Commissioners;

WHEREAS, Linsey McConnell has completed all requirements for membership and been approved by vote of the Victor Fire Department, Inc.; and,

WHEREAS, the Board of Fire Commissioners wishes to honor and approve volunteer firefighters requesting to serve with the Victor Fire Department and desire to satisfy all legal and insurance requirements for the benefit of our volunteers; now, therefore, be it

RESOLVED that the Board of Fire Commissioners hereby appoints Linsey McConnell to the Victor Fire Department's Hook & Ladder Company as Firefighter #199 upon a driver's license approval and the passing of a physical examination from Healthworks; and,

RESOLVED, that a copy of this resolution be forwarded to Chief Mark Eifert, the Victor Fire Department, Inc., and Linsey McConnell.

# g. Resolution #2022-0042 - Authorization to Contract with Davis Ulmer

On motion of Commissioner McConnell, seconded by Commissioner Turner, the following resolution was adopted: 5 Ayes;0 Nays

WHEREAS the Board of Fire Commissioners issued a Request for Proposals for Fire Alarm Monitoring & Inspection Services on March 8, 2022;

WHEREAS, the Board of Fire Commissioners have reviewed the results of the proposals, which are fully described in Attachment A; now, therefore, be it

RESOLVED that the Board of Fire Commissioners authorizes entering into a threeyear contract with Davis Ulmer for fire alarm monitoring and inspection services, effective May 1, 2022, at the cost per their schedule; and,

RESOLVED, that Treasurer McAdoo is authorized to sign any documents to execute the contract and a copy of this resolution be provided to Davis Ulmer.

#### 10. Executive Session

A motion was made by Commissioner Barry, seconded by Commissioner Turner, to enter Executive Session for the purpose of the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal, or removal of a particular person or corporation.
