a. Resolution #2022-0089 - Purchase Authorizations

b. Resolution #2022-0090 - Motion to approve budget transfers

WHEREAS, to maintain balanced budget lines within the 2022 budget, Treasurer McAdoo recommended inter-budget transfers as fully described in Attachment A; and,

WHEREAS the Board of Fire Commissioners have reviewed and discussed the transfers and found they are consistent with good financial practices; now, therefore, be it

RESOLVED the Board of Fire Commissioners approve the inter-budget transfers as shown.

c. Resolution #2022-0091 –Authorization for Chief Eifert to attend arson investigation training.

On motion of Commissioner Keyes, seconded by Commissioner McConnell, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, General Municipal Law 72-g and Victor Fire District Policies require training opportunities at the state level must be authorized by the Chief and approved by resolution of the Board of Fire Commissioners prior to attendance;

WHEREAS, Chief Mark Eifert is a certified Arson Investigator which requires periodic refresher and specialty training to maintain these credentials;

WHEREAS, the New York State Academy of Fire Science in Montour Falls, NY, has a Fire/Arson Investigation Seminar from November 15 – 17, 2022, which meets the needs of the continued training; and,

WHEREAS, Chief Eifert has authorized this training; and registration including room and board has been reserved for his attendance; now, therefore, be it

RESOLVED, that the Board of Fire Commissioners authorizes Chief Eifert to attend the Fire/Arson Investigation Seminar at the New York State Academy of Fire Science, utilizing the 270 vehicle from November 15 – 17, 2022;

RESOLVED, that any necessary expenses will be paid for by the Fire District as is consistent with the Travel Expense and School & Training policies;

RESOLVED, that the expenses for this training will be assigned to A3410.403.11.2 Training – NYS Fire Academy

d. Resolution #2022-0092 - Authorization for FF 263 to attend instructor training.

On motion of Commissioner Barry, seconded by Commissioner Keyes, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, General Municipal Law 72-g and Victor Fire District Policies require training opportunities at the state level must be authorized by the Chief and approved by resolution of the Board of Fire Commissioners prior to attendance;

WHEREAS, the New York State Fire Academy of Fire Science in Montour Falls, NY, has a Live Fire Instructor course scheduled on November 19 - 20, 2022;

WHEREAS, Firefighter Robert Wihlen has requested permission to attend this training to further his professional development as a firefighter;

WHEREAS, Chief Mark Eifert has authorized this training, recognizing there is a benefit to the Victor Fire Department in enhancing instructional resources; now, therefore, be it RESOLVED that the Board of Fire Commissioners authorizes Firefighter Wihlen to attend the Live Fire Instructor course in Montour Falls on November 19 – 20, 2022;

RESOLVED, that any necessary expenses will be paid for by the Fire District as is consistent with the Travel Expense and School & Training policies;

RESOLVED, that the expenses for this training will be assigned to A3410.403.13 Training – Paid FF

e. Resolution #2022-0093 -Authorization to Enter into Intermunicipal Agreement for In-Service Municipal Fire Training Program

On motion of Commissioner Barry, seconded by Commissioner McConnell, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS the Victor Fire District does not currently meet the requirements to establish an in-service training program for career personnel;

WHEREAS, Chief Eifert recognizes the benefit to the community and the department to provide the minimum level of annual in-service training requirements for career personnel;

WHEREAS, the Fishers Fire District has offered to provide in-service fire training to career firefighting personnel during their scheduled duty periods;

WHEREAS, the Fire District Attorney for Victor has prepared an intermunicipal agreement to further this purpose, as fully described in attachment A;

WHEREAS, the Board of Fire Commissioners have reviewed the agreement and found it meets the requirements stated above and is beneficial to the District; now, therefore, be it

RESOLVED that the Board of Fire Commissioners authorizes Chairman Jon McConnell and Chief Mark Eifert to enter into an inter-municipal agreement with the Fishers Fire District for the purposes stated above; and,

RESOLVED that a copy of this resolution be delivered to the Fishers Fire District and Ontario County Fire Coordinator Jeffrey Harloff.
