b. Resolution #2023-0042 -Establishment of new budget lines

WHEREAS, the guidance from the Office of the New York State Comptroller's Fire District Accounting and Reporting Manual separates capital outlay expenditures from contractual and personnel expenditures;

WHEREAS, the 2023 Budget does not separate capital and contractual expenditures; and,

WHEREAS, the Treasurer has worked with the Auditor to create new budget lines for capital expenditures and recommended inter-budget transfers from the existing budget as fully described in Attachment A; now, therefore, be it

RESOLVED the Board of Fire Commissioners approves the revisions to the 2023 budget as shown.

c. Resolution #2023-0043 - Appointment of Fire Training Instructor (part-time).

On motion of Commissioner McConnell, seconded by Commissioner Barry, the following resolution was adopted: 4 Ayes; 1 Nays (Commissioner Turner)

WHEREAS, the Board of Fire Commissioners established a part-time paid position of Fire Training Instructor in Resolution #22-97;

WHEREAS, Ontario County Civil Service has classified this position as competitive under Personnel Officer Classification Certification #8-2023;

WHEREAS, the District wishes to make a part-time provisional appointment for this position; and

WHEREAS, Chief Eifert recommends the appointment of Ben Cramer to the position of Fire Training Instructor with the Victor Fire District; now, therefore, be it

RESOLVED that the Board of Fire Commissioners hereby appoints Ben Cramer to the position of Fire Training Instructor, effective April 12, 2023, on a part-time (not to exceed 50 hours per month), provisional basis at a rate of \$28 per hour; and,

RESOLVED, that a copy of this resolution be forwarded to Ontario County Civil Service, and Mr. Cramer.

d. Resolution #2023-0044 - Approval of Car Seat Program

On motion of Commissioner McConnell, seconded by Commissioner Barry, the following resolution was adopted: 5 Ayes; 0 Nays

WHEREAS, three individuals from Victor Fire District completed the National Child Seat Passenger Safety Certification Training;

WHEREAS, there are ongoing opportunities for grant opportunities to fund child seat safety programs through the New York State Governor's Traffic Safety Committee; and

WHEREAS, the Board of Fire Commissioners have reviewed the Child Passenger Safety Seat Program as fully described in Attachment A, and recognizes the opportunity to enhance our service to the community by establishing a sustainable car seat check program; now, therefore, be it

RESOLVED the Board of Fire Commissioners approves the Child Passenger Safety Seat Program; and

RESOLVED to authorize the District Treasurer to file for any available grants from the Governor's Traffic Safety Committee.
